CELEBRATING EARTH DAY: THE ENVIRONMENTAL BENEFITS OF PROPANE

Earth Day, celebrated on April 22nd each year, serves as a global reminder of our collective responsibility to protect and preserve the environment. A tree-planting initiative within U.S. national forests represents just a fraction of propane's eco-conscious narrative.

Venturing into any of America's 154 national forests, one encounters vast expanses of trees. These arboreal giants not only captivate with their beauty but also perform a myriad of essential ecological functions, from oxygen production to carbon sequestration, soil and water conservation, and wildlife support. Interestingly, some of these trees owe their existence to propane.

Each esteemed guest featured on the Path to Zero podcast, led by Propane Education & Research Council (PERC) President and CEO Tucker Perkins, is invited to select a national forest where a tree will be planted in their honor. PERC then collaborates with one of three tree-planting initiatives — Trees Remember, A Living Tribute, and The Gifted Tree — to fulfill the guests' requests. To date, Path to Zero participants have dedicated 64 trees across national forests spanning 26 states, including notable locations such as Sierra National Forest in California, Mark Twain National Forest in Missouri, and Tongass National Forest in Alaska.



While the United States boasts an estimated 3 trillion trees, the National Forest Foundation reported over 8 million trees planted in national forests in 2022 alone. PERC's contribution of 64 trees may seem modest in comparison, but each planted tree represents a positive stride towards environmental stewardship.

But the environmental narrative extends beyond tree-planting endeavors. Propane, a low-carbon fuel alternative, emits significantly fewer pollutants than an equivalent amount of electricity sourced from the U.S. grid. A notable example resides in Maine's Acadia National Park, where propane fuels the Island Explorer buses, ensuring clean transportation while

safeguarding the park's air quality and natural habitats. Over two decades, these propane-powered buses have curbed carbon emissions by 27 tons and prevented the release of 41 tons of smog-inducing pollutants.

Moreover, propane's inherent non-toxic and non-poisonous nature prevents soil and groundwater contamination, further bolstering its eco-credentials. With ongoing advancements in renewable propane technology, the promise of even greater environmental benefits looms on the horizon.

This Earth Day, let us celebrate the multifaceted contributions of propane, from fostering tree growth in national forests to mitigating carbon emissions and championing sustainability.
